

THE CONVENT OF CLUJ-MĂNĂȘTUR'S ARCHIVE KEPT AT THE BATTHYANEUM LIBRARY (I)

1. *Brief history of the Convent of Cluj-Mănăștur and its archive*

“*Cum ea que aguntur in tempore vetustatis ne labantur, ideo patrocinio litterarum solent roborari*”,¹ implores the convent of the monastery of St Virgin Mary of Cluj-Mănăștur in a letter from the second half of the fourteenth century. Such a cause is not singular in medieval written sources from this geographical and temporal area. Beyond displaying the scribe's knowledge of Latin, this passage also reflects the importance of the letter, that of preserving the facts, which are recorded in the charter.² The need to register information is generated by the legal issues that the documents often contain regarding property rights. Thus, the growth of charter's issuance is determined by the pragmatic need of society, that of guaranteeing the rights of ownership.³ Initially, the royal chancellery was the only institution that had the right to issue documents. The increasing demand of charters determined the kings of Hungary to give the right to issue documents to other institutions. The places of authentication are among the offices to which the kings of Hungary gave the right to draw up documents with legal validity, strengthened by the use of their own and authentic seals.

The places of authentication (*loca credibilia*) are ecclesiastical institutions, which beside their ecclesiastical duties, play an important role for the laity.⁴ These are the offices to which the laity turned

to resolve various legal issues: inheritance cases,⁵ divisions,⁶ sales,⁷ mortgages,⁸ prohibitions,⁹ and so on. The local and royal authorities also requested the places of authentication to make the field investigations of some cases or to fulfil legal decisions.¹⁰ The *loca credibilia* thus became indispensable institutions both for the laity, by certifying their rights, and for the authorities, by solving some cases that had been submitted to them.

In the Kingdom of Hungary, throughout the Middle Ages, around eighty places of authentication were active, four of which were located in the Transylvanian Voivodship.¹¹ Among the most important places of authentication in Transylvania, next to the chapter in Alba Iulia, was the convent of the Benedictine monastery of St Virgin Mary in Cluj-Mănăştur. The abbey, founded in the eleventh century, began to issue documents with its own seal and in significant numbers in the fourteenth century. The important role that the convent of Cluj-Mănăştur played in the history of medieval Transylvania and also of the Kingdom of Hungary has led many historians to focus their studies on this place of authentication. The convent of Cluj-Mănăştur has been approached by researchers from various points of view: that of its origin,¹² its attributions in issuing documents and fulfilling the mandates received from secular authorities,¹³ the forms of document authentication,¹⁴ the false documents issued,¹⁵ the ecclesiastic and lay

members of this institution,¹⁶ the territorial jurisdiction,¹⁷ and the library,¹⁸ as well as of the institution's activity during the principality and the changes that occurred after secularisation.¹⁹

In the present study, I will discuss another role of the place of authentication, that of keeping written sources. Requests of charters by the petitioner also imply the elaboration of a pariah copy of it or its registration in the protocol of the institution.²⁰ The registration of the issued letters has the role of both guaranteeing the rights inscribed in the document and preventing the further issuance of false documents.²¹ This latter role is suggested by the multiple requests that the local or royal authorities address to the place of authentication to verify the testimonies presented to them.²² The verification of testimonies was undertaken both by on-site research and the questioning of those who had data about the case²³ and by checking the validity of information in the charters kept at the place of authentication.²⁴ The movable property of the convent, the letters issued and the protocol of the institution, as well as the seal of the place of authentication, were deposited in the sacristy or archive of the convent,²⁵ which was in charge of a canon, named the custodian.²⁶

In the introduction to the volumes regarding the protocol of the convent in Cluj-Mănăştur, Jakó Zsigmond gives a list of the institution's staff. According to the data extracted by the historian, the first custodian is attested in the first half of the fourteenth century.²⁷ This position was held until the middle

of the sixteenth century, when, in the Diet of Turda, held on June 1, 1557, was established the appointment of four lay requisitors at the chapter of Alba Iulia and at the convent of Cluj-Mănăştur, who would be remunerated by the prince. From that moment on, the place of authentication functioned like an institution of the principality. The convent of Cluj-Mănăştur had the same fate as the cathedral chapter of Alba Iulia, both to become secularised institutions.²⁸ However, they returned under the jurisdiction of the Catholic Church, after multiple requests, only in the first half of the eighteenth century.²⁹ At that time, the foundations of the national archive were laid in Hungary, whose archival material gradually grew through the intense activity of archivists, such as Lajos Batthyány, János Török and Gyula Pauler. The latter was chief archivist of the National Archives in Buda, from 1893 until his death, in 1903. It was he who took care of moving the archives of the chapter from Alba Iulia and the convent from Cluj-Mănăştur to Buda. For this purpose, Gyula Pauler travelled to Alba Iulia and Cluj-Mănăştur to collect the documentary material that would be taken to Buda, in 1884.³⁰ A canon from Alba Iulia, Antal Beke, was in charge of the selection of documents of national interest, kept in the two archives. On this occasion, he made a catalogue of the documents to be extracted, as well as registers of the letters kept in the two archives. The registries of the documents kept in the archive of the convent in Cluj-Mănăştur were published by Antal Beke in various editions of the *Történelmi Tár journal*,³¹ which were later included in an edition published in Budapest in 1898.³²

Antal Beke's activity was not limited to editing the charters in summary form, but the canon was one of the promoters who requested that the archives of the convent in Cluj-Mănăştur be joined to the archive of the chapter in Alba Iulia. His request would be answered only in 1937, when the convent's archive would join the chapter's archive at the Batthyaneum Library, in Alba Iulia, where it is still kept today.³³

According to the catalogue made by Antal Beke at the end of the nineteenth century, the convent of Cluj-Mănăştur's archive, kept at the Batthyaneum Library, contained 510 charters dated up to 1600. Of these, 72 are from the thirteenth-fourteenth centuries; five from the thirteenth century and 67 from the

fourteenth century. In the thirteenth century, two documents were issued by the chapter of Alba Iulia and three by the bishop of Transylvania. In the fourteenth century, most preserved documents were issued by the voivode of Transylvania, followed by the chapter of Alba Iulia, the vice-voivode of Transylvania, the convent of Cluj-Mănăştur, the king of Hungary and so on. From the point of view of the preservation form, the documents from the thirteenth century are only in the *transsumptum* form, while the documents from the fourteenth century are mostly preserved in the original.

In the years that followed the catalogue being made by the Transylvanian canon, microfilms were made of the documents kept at the Batthyaneum Library, and those dated up to 1526 were then uploaded to the webpage of the Hungarian National Archives.³⁴ In this way, the access of historians to the medieval charters was facilitated. However, some images are illegible,³⁵ a fact that makes it difficult both to read the charters and especially to analyse some important details for researching them. In this context, it is imperative to return to the original documents. Often, however, even though the archive keeping the document is known, its detection is difficult, because during 1961-1975 the archive and the documents kept at the Batthyaneum Library were reorganised and received new catalogue numbers.³⁶ Thus, the archival references mentioned by Antal Beke no longer coincide with those in the library's current inventory. For this reason, the present study was carried out, which contains a catalogue of medieval documents from the archive of the convent from Cluj-Mănăştur, kept at the Batthyaneum. The catalogue includes information regarding the date of the charter, the issuer, the place of issue, the form of preservation, the type of seal, the underlying material, the share of the document from the Batthyaneum Library, from the portal of the Hungarian National Archives and the editions of the documents. It should be noted that the editions are selective. These mostly include the registers made by Antal Beke, *Documente privind Istoria României*, *Documenta Romaniae Historica*, and *Erdélyi Okmánytár*. The first part of the study includes the documents dated in the thirteenth-fourteenth centuries, while the letters from the fifteenth-sixteenth centuries will represent the material for future works.

Following the research undertaken in the archive of the convent of Cluj-Mănăştur at the Batthyaneum Library, 73 charters from the thirteenth-fourteenth centuries were found. Seven letters are from the thirteenth century, of which four documents were issued by the bishop of Transylvania, two by the chapter in Alba Iulia and one by the convent of Cluj-Mănăştur. None of the documents are preserved in their original form, but six documents are in transsumpt form and one in summary.

Sixty-three letters are preserved from the fourteenth century. The most documents were issued by the voivode of Transylvania, followed by the chapter of Alba Iulia, the vice-voivode of Transylvania, the king of Hungary, the convent of Cluj-Mănăştur, the bishop of Transylvania, the county courts of Cluj and Turda and the chapter of Oradea. Most documents are preserved in original form, but there are also letters preserved as transsumpts and modern copies (see Annex.).

Comparing the catalogue of the documents kept today at the Batthyaneum Library with those mentioned by Antal Beke, it is found that 11 documents from the fourteenth century have been lost,³⁷

while two documents are preserved today only in modern copies.³⁸ The loss is partially compensated quantitatively by three documents from the fourteenth century which the Transylvanian canon did not detect at the end of the nineteenth century.³⁹ Apart from the documents mentioned in the annex of this study, four charters are mentioned in a list of documents regarding Vințu possessions. The documents are not listed in the inventory below, because only the year and the issuer are known, with no other details regarding the contents of the letter.⁴⁰ However, pointing them out is important for the knowledge of writing practice in the medieval period.

The medieval charters fund of the place of authentication, the chapter of Alba Iulia and the convent of Cluj-Mănăştur, preserved today at the Batthyaneum Library, in Alba Iulia, are often consulted only through the portal of the Hungarian National Archives. The digitisation of medieval documents represents an important tool both for facilitating researchers' access to the primary source and for the preservation of letters. The microfilms of medieval documents from the Batthyaneum Library, uploaded to the webpage of the Hungarian National Archives have, as previously mentioned, low image quality. For this reason, some of the charters cannot be read and this situation affects the research of the documents. Such impediments, encountered in the research of the charters on the Hungarian portal, can be overcome by a physical consultation of the letters or by a new digitisation of them. In recent years, the Batthyaneum Library staff have started digitising the documentary collection, the image being uploaded to the portal of the Romanian National Library.⁴¹

The Batthyaneum Library, a rich institution in movable heritage, has aroused the interest of historians, especially through its old book collection⁴² and less through charters from archive of places of authentication⁴³. Medieval charters, although some of them can be consulted on the previously mentioned portals, are important primary sources which need new analyses and interpretations that sometimes require research them in original form. The re-inventory of documents, as well as the wrong dating of some letters, makes it difficult for the researcher to find the original. For these reasons, the present study was carried out, which through the catalog, shown in the annex, aid to research the original form of
